Re: Anthony J. Ciaccio- Water Treatment Plant Operator – Out of Title Pay

As you are aware, William Manzo, Senior Treatment Plant Operator was involved in a serious and unfortunate motor cycle accident that resulted in a very long sick leave absence from his position at the Chadwick Lake Water Filtration Plant. Due to this absence, Anthony Ciaccio, Water Treatment Plant Operator, without hesitation, stepped up to help fill this void in leadership at the filter plant. He has done a great job filling in for Mr. Manzo and has proven to be an asset to the Town and extremely helpful to me.

As per section 3.4 – Out of Title Work of the current CSEA Agreement, I am requesting that Mr. Ciaccio be paid out of title pay for the period of time during Mr. Manzo's absence.

Please note the current step and grades: Senior Water Treatment Operator - Grade 20, Step 15 - \$27.5397 per hour Water Treatment Plant Operator - Grade 17, Step 15 - \$25.1097 per hour

Based on an 8 hour day and 143 days of coverage as Senior Operator, the difference in rate of pay between the current step increments of \$2.43 per hour would calculate to a total amount of \$2779.92. The days of coverage would start on October 29, 2012 and include up to May 16, 2013, the anticipated return to work date for Mr. Manzo.
