## INTRODUCTORY LOCAL LAW NO. \_\_OF THE YEAR 2022 AMENDING SECTIONS 166-5 AND 166-19 OF CHAPTER 166 ENTITLED "TAXATION" OF THE MUNICIPAL CODE OF THE TOWN OF NEWBURGH: EXEMPTIONS FOR PERSONS SIXTY-FIVE YEARS OF AGE OR OVER AND FOR PERSONS WITH A DISABILITY

BE IT ENACTED by the Town Board of the Town of Newburgh as follows:

## SECTION 1 - TITLE

This Local Law shall be referred to as "A Local Law Amending Sections 166-5 and 166-19 of Chapter 166 entitled 'Taxation' of the Municipal Code of the Town of Newburgh: Exemptions for Persons Sixty-Five Years of Age or Over and for Persons with a Disability".

# SECTION 2 - AMENDMENT TO SECTION 166-5

Section 166-5 "Exemption Granted" of Chapter 166 entitled "Taxation" of the Code of the Town of Newburgh is hereby amended to read as follows:

## "§ 166-5. Exemption granted.

Real property in the Town of Newburgh owned by one or more persons, each of whom is 65 years of age or more, or real property owned by husband and wife, one of whom is 65 years of age or over, or by siblings, one of whom is 65 years of age or over, shall, depending on the annual income of said persons, be exempt from taxation by the town to the extent of the percentage of the assessed valuation thereof set forth in the following Schedule of Exemptions.

# SECTION 3 - AMENDMENT TO SECTION 166-19

Section 166-19 "Exemption Granted" of Chapter 166 entitled "Taxation" of the Code of the Town of Newburgh is hereby amended to read as follows:

## "§ 166-19. Exemption granted.

Real property owned by one or more persons with disabilities, or real property owned by a husband, wife or both, or by siblings, at least one of whom has a disability and whose income is limited by reason of such disability, shall be exempt from taxation by the town to the extent of the percentage of the assessed valuation thereof set forth in the following schedule of exemptions. (Note: Pursuant to the powers given to a municipal corporation in Real Property Tax Law § 459-c(1)(b), the figure represented herein as "(M)" shall be \$50,000.00 in the Town of Newburgh.)

(M) + \$4,800 or more but less than (M) plus \$5,700	20%
(M) \$5,700 or more but less than (M) plus \$6,600	15%
(M) plus \$6,600 or more but less than (M) plus \$7,500	10%
(M) + \$7,500 or more but less than (M) plus \$8,400"	5%

## SECTION 4 - NO RETROACTIVE EFFECT

The annual income limits for exemptions for persons 65 years and older and persons with a disability which are increased by the amendments contained in Sections 2 and 3 above shall apply to assessed valuations for the March 1, 2023 taxable status date and thereafter. The amendment shall not apply retroactively.

## SECTION 5 - VALIDITY

The invalidity of any provision of this Local Law shall not affect the validity of any other provision of this Local Law that can be given effect without such invalid provision.

## SECTION 6 - EFFECTIVE DATE

This Local Law shall take effect immediately when it is filed in the Office of the New York State Secretary of State in accordance with Section 27 of the Municipal Home Rule Law.
