1 Orange Lake Motel - UHaul Rentals 2 CHAIR EWASUTYN: Good evening, ladies 3 and gentlemen. I'd like to welcome everyone to the December 2nd Planning Board meeting. We 4 5 have two items on the agenda this evening. At this point we'll call the meeting to 6 order with a roll call vote. Stephanie. 7 8 MS. DeLUCA: Present. 9 MR. MENNERICH: Present. 10 CHAIR EWASUTYN: Present. 11 MR. DOMINICK: Present. 12 MR. WARD: Present. 13 MR. CORDISCO: Dominic Cordisco, planning board attorney. 14 15 MR. CAMPBELL: Jim Campbell, code compliance. 16 CHAIR EWASUTYN: At this time I'll turn 17 18 the meeting over to Stephanie DeLuca. (Pledge of Allegiance recited.) 19 MS. DeLUCA: Please silence your cell 20 21 phones. 22 CHAIR EWASUTYN: You know what, I'm 23 surprised that -- I'm surprised. Charlie is so 24 It's so unusual. qood. 25 MR. DOMINICK: Nobody.

All right, let 3 the record show that the first item on the agenda, Serviss, two lot subdivision, project 4 5 number 21-07, no one is present this evening to represent the applicant for the subdivision. 6 7 The second item of business this evening is Orange Lake Motel - UHaul Rentals. 8 It's an amended site plan. It's located on 427 9 South Plank Road. I think the zoning is 10 incorrect there, it's a B zone. And it's being 11 12 represented by Mr. Patel. 13 Mr. Patel. MR. PATEL: Good evening. Thank you 14 15 for allowing me to appear before the Board, 16 Mr. Chairman. We were here in August, a few months 17 ago we first appeared. We had a couple of 18 19 setback issues, so we were sent to the Zoning The Zoning Board at its last meeting 20 Board. 21 granted us the variances, so we are back here 22 again today for your approval. This is a change 23 of use application for an existing motel. The 24 motel owners want to start a UHaul rental business by just installing a 60 by 60 parking 25

1 Orange Lake Motel - UHaul Rentals area in the back of the motel. 2 CHAIR EWASUTYN: Before we open it up 3 to the Board for discussion, have you received 4 5 Pat Hines' review comments? MR. PATEL: I have not. 6 7 CHAIR EWASUTYN: Okay. Let me give you a copy of them. 8 9 MR. PATEL: Thank you. CHAIR EWASUTYN: Because procedurally 10 there's some steps we have to complete. 11 12 We'll open up discussion, Board members, starting off with Stephanie. Any 13 14 auestions? 15 MS. DeLUCA: I'm going to defer to Just a concern regarding the -- I'll 16 John. Never mind, I'll pass. 17 pass. 18 CHAIR EWASUTYN: Ken Mennerich. MR. MENNERICH: I'll wait for John to 19 talk about lighting. 20 21 CHAIR EWASUTYN: Dave Dominick. 22 MR. DOMINICK: Not at this time. 23 John Ward. CHAIR EWASUTYN: 24 MR. WARD: I see you have no lights, period, on your plan or anything. I took a ride 25

I'm just asking, I'm not asking for 3 posts up and all this like a normal parking lot, 4 5 which we usually require. I'm saying for your safety and everything else, it could be a 6 7 floodlight, whether it's a motion detector, when people go back there, whether for safety-wise, 8 even though your hours are during the day, it's 9 10 just a habit to see. It's pitch black, you 11 know. 12 MR. PATEL: I may have to check on that. 13 There is -- there are lights on the 14 buildina. 15 MR. WARD: Right. 16 MR. PATEL: That go toward that side. But I'll take your word if you say you drove by. 17 I drove all the way back and 18 MR. WARD: 19 behind the building, and I saw your propane tank 20 on the left --21 MR. PATEL: Yeah. 22 MR. WARD: -- and everything else. But 23 what I'm saying is where you are proposing, it's black. 24 MR. PATEL: That's next to the Dumpster 25

1 Orange Lake Motel - UHaul Rentals 2 area. 3 Yeah. MR. WARD: 4 MR. PATEL: Okay. 5 MR. WARD: It's past that, yeah. But it's just --6 7 MR. PATEL: No, I mean, I understand, definitely. If it's that pitch dark --8 9 MR. WARD: Yeah. MR. PATEL: -- then, you know, I'll 10 take your word for it. I'll check in with the 11 12 owner. We'll put something on the wall just to, or turn the light that's there. 13 14 MR. WARD: Right. A motion. vou know. 15 MR. PATEL: Yeah. No, good point. 16 we'll take a look at it. MR. WARD: And the other thing is, 17 you're proposing four vehicles to be in there. 18 If you expand, if you make it six to ten, say 19 business does really good, I think you should be 20 coming back here to blacktop the rest of it to 21 22 make it the right way, instead of just expanding 23 parking on dirt and everything else. There's a 24 procedure. MR. PATEL: That's up to the Board. 25 If

WARD: Because I can see you 5 parking four, and all of a sudden there's six of them, you know, overdoing it, where it's just 6 7 how would you -- we trust everything, but to make it on paper to make it right. 8 9 MR. PATEL: Yeah. 10 Please. MR. WARD: 11 MR. PATEL: Sure. 12 MR. WARD: Thank you. 13 MR. PATEL: No problem. Thank you. 14 CHAIR EWASUTYN: Okav. Anv other 15 questions, or Jim Campbell? 16 MR. CAMPBELL: No comments in addition to what Pat has already written. 17 CHAIR EWASUTYN: I think Pat is saying 18 19 there now that you finished with the ZBA we do 20 have to refer it, because it's close to a state 21 highway, to the Orange County Planning 22 Department. 23 MR. PATEL: Okay. CHAIR EWASUTYN: And also refer to the 24 25 DOT I think it's saying.

3	CHAIR EWASUTYN: So if you'll make, Pat
4	is away, but I'm sure he'll be back for the
5	start of the new week. You'll work with Pat as

7	Planning Department and also to the DOT.
8	MR. PATEL: Okay. So I'm assuming that
9	has not been done yet?
10	CHAIR EWASUTYN: No. We couldn't do
11	that until we receive
12	MR. PATEL: The Zoning Board.
13	CHAIR EWASUTYN: ZBA approval.
14	MR. CORDISCO: Yes. If I may, it
15	requires formal action by this Board to send it
16	to the County Planning Department and the DOT.
17	MR. PATEL: Okay.
18	MR. CORDISCO: This is your first
19	appearance back.
20	MR. PATEL: So I should get in touch
21	with Pat next week?
22	MR. CORDISCO: He'll need additional
23	copies in order to make those referrals, so
24	he'll work with you on getting those in and
25	making that submission.

CORDISCO: When the plans go, if I may, Mr. Chairman, when the plans go to the 4 5 Orange County Planning Department, they have thirty days to review and comment on the 6 7 proposal, during which time this Board can't take action. So getting that referral out, you 8 9 know, at your convenience would be helpful for 10 your timing. 11 John Ward. CHAIR EWASUTYN: 12 MR. WARD: One more question. It came 13 up at the Board, Board business. Are you 14 backing the vehicles in for the parking or --15 No. The way it's laid out, MR. PATEL: 16 it just uses the same driveway that's there. Yeah. 17 MR. WARD: MR. PATEL: And then they go in head 18 19 first. 20 MR. WARD: Right. 21 MR. PATEL: And that's how it's going 22 So when they come out they're right to be. 23 there. MR. WARD: Are they backing out that 24 25 way?
