




ENERAL *LANDSCAPING* NOTES:

유류 LANDSCAPE CONTRACTOR IS RESPONSIBLE TO LOCATE AND VERIFY LOCATION ALL UTILITIES ON SITE PRIOR TO CONSTRUCTION OR INSTALLATION.

ALL PLANT MATERIAL SHALL BE NURSERY GROWN AND SHALL CONFORM TO STANDARDS OF AMERICAN STANDARD FOR NURSERY STOCK, THE AMERICAN ASSOCIATION OF NURSERYMEN, LATEST EDITION. 井

L PLANTS AND WORKMANSHIP SHALL BE UNCONDITIONALLY GUARANTEED FOR CALENDAR YEARS. CONTRACTOR SHALL REMOVE STAKING AND GUYING AT END GUARANTEE PERIOD.

ALL LANDSCAPE INSTALLATIONS SHALL BE MAINTAINED ON A REGULAR BASIS, AND SHALL NOT BE ALLOWED TO TAKE ON AN UNSIGHTLY APPEARANCE (EXCEPT FOR NATURAL AREAS WHICH SHALL BE ALLOWED TO GROW NATURALLY WITH A MINIMUM OF MAINTENANCE).

CONTRACTOR SHALL FIELD STAKE THE LOCATIONS OF ALL PLANT MATERIAL PRIOR TO INITIATING INSTALLATION FOR THE REVIEW AND APPROVAL OF THE OWNER'S REPRESENTATIVE.

ALL LANDSCAPING PLANT MATERIALS — TREES, SHRUBS, GROUNDCOVERS AND PERENNIALS SHALL BE PLANTED AS SHOWN IN DETAILS. BACKFILL MIX FOR PLANTING BEDS SHALL BE A MIX OF TOPSOIL, WELL—ROTTED COMPOST AND FERTILIZER. PROVIDE PLANTING PITS AS INDICATED ON PLANTING DETAILS. IF WET SOIL CONDITIONS EXIST THEN PLANTING PITS SHALL BE EXCAVATED AN ADDITIONAL 12" AND FILLED WITH CRUSHED STONE. Ŧ

ALL PLANTS SHALL BEAR THE SAME RELATIONSHIP TO FINISHED GRADE AS WHICH EXISTED IN THE NURSERY.






