Dear Mr. Ewasutyn:

As part of the ongoing construction of the Shaft 5B site and shaft, DEP would like to work on Saturdays. Our goal in pursuing the Saturday work is to proactively manage the construction schedule, allowing DEP to control the duration of the project which is presumably in the interests of the Town of Newburgh, as well.

Based on the project's environmental impact statement (EIS)¹ as well as the Planning Board site plan approval² and the letter agreement³ covering the project, construction activities for site preparation are to be conducted up to six days per week for two shifts, from 7:00am to 11:00pm. Shaft construction activities are limited to five days per week, 24 hours per day.

DEP is now proposing a slight departure from the agreed hours of work to conduct shaft construction activity on Saturdays – with the exception of blasting and trucking – from 7:00am to 7:00pm, the hours listed in §125-9 D.(2) of the Town Code, Noise and Illumination Control. Work would include, but not be limited to, drilling blasting holes, rock bolting, mesh installation, grouting, concrete formwork erection and stripping, concrete placement, and equipment maintenance. The majority of this work would occur inside the shaft and resultant noise levels would be reduced relative to site work. Site work, as already agreed, would continue on Saturdays during the prescribed timeframe, as well. And, to reiterate, blasting and offsite trucking would not be conducted during the Saturday work.

Please note that the noise mitigation plan³ developed for the project will be in force during the Saturday work, as it is for the weekdays. Should an exceedence of the prescribed noise levels occur, corrective action will be taken immediately in accordance with the plan.
