1. Adjoiners' Notices for the amended site plan must be circulated.
2. The project proposes the construction of an additional 40 passenger vehicle parking spaces.
3. An updated SWPPP will be required. Coverage under the NYSDEC Stormwater Permit should be reactivated.
4. A detailed tree survey has been provided. The tree survey identifies the removal of 60% of the specimen trees exceeding the 50% threshold in the R3 zoning. Replanting or restitution plan should be provided including calculations for the excessive removal of the specimen trees.
5. The discharge location for the revised stormwater management facility including all piping should be depicted on the grading and drainage plan.
6. The limits of disturbance must be increased to include the grading for the extended detention pond expansion.
7. The revised parking calculations should be added to the plans identifying the 220 seats, with a total of 110 parking spaces. Previous parking calculations identified 1 space for every 3 seats. It is requested, the applicants confirm that no additional seating or more intensive use of the building is proposed, which would impact the subsurface sanitary sewer disposal system design.
8. County Planning referral is required as the project is located within 500 feet of a state highway.


