1.) I am the Applicant in a pending "Application for Interpretation" before this Board.

2.) At the initial public hearing held in this matter on June 26, 2014, my attorney submitted to the Board that my prospective use of the premises would be analogous to the operation of a "convenience store" (without gasoline fueling stations), as a permitted accessory use in the current zone.

3.) By way of supplementing the comments of my attorney at that meeting, I submit herewith and attach hereto, literature from Dunkin Donuts, confirming that it has negotiated with the Wrigley Company "front counter merchandising", which would include a display for k-cups, fresh produce, mints, gum and newspapers.

4.) 5.) Moreover, there will be no baking done on the premises. The product arrives in a frozen state and is re-heated on the premises.
