These accomplishments are not of my 22 accomplishments, but the entire Board, and many 23 of them are dedicated Town employees that actually made them possible. I want to read them 24 25 off. I don't have to tell you, but it's been a

very difficult year to do anything. I just hope
and pray it gets better in 2021.

Here's some of the things that we've 4 done here in 2020. We obtained ownership of the 5 Desmond campus through a grant from the Kaplan 6 7 Family Foundation. We promoted four police sergeants. We made a new DARE Officer. 8 We 9 obtained and assisted with a grant for a water 10 and sewer feasibility study on the west side of 11 Orange Lake. The Town Clerk implemented an 12 electronic FOIL software system making it easier to access public records. The Clerk also issued 13 14 over 200 marriage licenses, double from 2019. 15 Highway resurfaced 15 miles of roadway. We 16 completed a zoning text change to allow daycare 17 centers and preschool in the B Zone. We began 18 work on a tree preservation local law. We 19 attained a grant for the Justice Court, a JCAP 20 grant. We purchased property, additional 21 property, to protect the water district. We 22 joined the west side of Apple Valley with the 23 east side of Apple Valley, a waste and treatment 24 plant, eliminating the old plant on the west side 25 by crossing under 9W. We obtained a grant also

2 for improvements on this project on the east side of 9W. We received funding for a DWI program. 3 We made a new Commissioner of Parks and 4 Recreation, James Presutti. We've done design 5 engineering for the Elmhurst Avenue culvert 6 7 replacement which is due to be replaced soon. We passed a local solar and wind energy exemption 8 9 law. We extended our agreement with Orange 10 County for Dial-A-Bus. We dedicated Tarben Road 11 as a new road. We passed a local law for records 12 retention. I'm trying to follow this one. We 13 completed renovations of 21 Hudson Plaza which is 14 a donated building to the Town from Dano which 15 became the new home for Code Compliance and a 16 section for an animal shelter. We received a 17 \$175,000 grant to renovate this for them.

18 I want to especially thank Councilman 19 Paul Ruggiero for his help in overseeing the 20 construction and saving the Town large amounts of 21 money by doing so. Because of the new 21 Hudson 22 Plaza space, we moved Engineering and the Water 23 and Sewer Department officers into the former 24 Code Compliance building at 380 Gardnertown Road. 25 This move made much needed space for Charlene

1

Black and the personnel office in Town Hall. We moved the Water and Sewer Department from the public service building, which was part of the courthouse upstairs, which created much needed space for the Justice Court. So all those moves we've done. We picked up a lot more space and operate more efficiently.

9 We've done a proclamation for small 10 businesses for the Saturday after Thanksgiving. 11 We approved a budget for 2021, keeping it under 12 the 2 percent cap. So that's accomplishments.

13Now I'm going to read our goals in a14second for 2021, as far as I'm concerned.

With that, I think I'm going to go
first to Betty Greene, if she has any comments or
plans for the new year.

18 Betty?

MS. GREENE: Well, I am very proud of all the Board Members and all the employees that helped with all the changes we accomplished in 2020.

I have a number one hit parade of something that I would like to see done, and I've mentioned it to the Board and I think they're in

2 agreement that we review and make any revisions that need to be done in our comprehensive plan. 3 As the Town grows, we have to stay with the 4 growth and take care of long-time residents and 5 new residents and work it out so that the Town 6 7 moves forward. So that's my big goal for 2021, is that 8 9 we redo and review the comprehensive plan. 10 SUPERVISOR PIAQUADIO: Very good, 11 Betty. And it's a good one. 12 With that, I'm going to ask Councilman 13 Ruggiero, any comments? 14 MR. RUGGIERO: Betty, I agree with you 15 on the comprehensive plan. 16 MS. GREENE: Thank you. 17 MR. RUGGIERO: We need to address that 18 and we need to look at that again. It's been long overdue. That is definitely a goal. 19 20 Also, getting the Desmond Estate up and 21 running and having classes, getting that out to 22 the public. 23 MS. GREENE: I agree with you. 24 MR. RUGGIERO: That's my main two 25 qoals.

As far as goals, I'm excited about the Desmond and whatever Jimmy Presutti and everybody else needs. I'm excited about that. I know Anthony LoBiondo is very much with the rowing and kayaking. I'm hoping to get the property we have on the river to get going. I know Anthony is going to be jumping right on that.

10 Speaking of Anthony, we have both 11 Anthony and Paul Ruggiero, both small business 12 owners. Anthony, when he joined the -- got onto 13 the Board, he helped me out a lot with all the 14 small businesses that we help out. I also talked 15 to Bill Fiorante from the County to help out with 16 businesses, big and small, to get involved in the I know we have some big ones and small 17 Town. 18 ones coming that I'm very excited about.

19One thing, Gil, that you didn't mention20is that we just recently also approved body21cameras for our Town police officers. That's22something that Scott and I had talked about a few23months ago. 2 was, I believe, paid for by forfeiture funds. So
3 it was a win/win for our Town.

Just picking up on a couple of things 4 that Scott had mentioned. As a small business 5 owner, I'm an attorney with my wife, Julianna, 6 7 and we know the struggles that people are going through due to COVID and the changing of the 8 9 environment completely. As far as the Town is 10 concerned, we assisted in the fall in the local 11 expo fall feasts. We had a very good turnout. We got I think a lot of help out to some of the 12 13 small businesses. We want to continue along that 14 line in assisting and promoting small businesses. We've talked with some of the business owners 15 about a small business alliance. 16 That's 17 something that I know Scott and I, and Paul as 18 well, are going to be working on again.

You mentioned our waterfront property. A fantastic, beautiful area. Given the circumstances, again we've really had an opportunity to see how important our green spaces are. Chadwick Lake Park has become a jewel in this area, and we're very lucky to have it. Our goal should be to try to copy, mimic the success

SUPERVISOR PIAQUADIO: All right. б 7 Thank you, Anthony. So real quick now I want to go into 8 9 what the plans for 2021 are, as I see them. 10 Recreation programs under the leadership of James 11 Presutti, our Commissioner, and Jason Seeley 12 basically remain the same with one great 13 addition. The Town has obtained ownership of the 14 Desmond campus through the generosity of the 15 Kaplan Family Foundation. A special thank you to 16 Mr. Kaplan and his daughter, Joan. The Town, as 17 you know, you probably heard this several times, 18 but we plan to reinstate educational programs and trails in the arboretum on the 26-acre park. 19 20 Hopefully we will have some programs in place by 21 the spring, but this will depend on the health of 22 the nation. 23 Let's talk about police. 2 Department under the leadership of Chief Bruce Campbell to provide safety for all our residents. 3 All officers will be equipped with Body 1 4 The purchase order has already been 5 cameras. б placed. Again, it was with drug seizure money. 7 It's to better keep a record of what happens when encounters are questioned. We will continue to 8 9 have a police department that is capable, 10 educated and always ready to help and serve our 11 residents while always being accountable for their actions. And we will deliver a plan in 12 13 accordance with the Governor's Executive Order 203. 14

15 With that, let's go to Highway. The 16 number of Highway employees will remain the same 17 to keep our 170 miles of road passable and open 18 and safe. We will complete approximately the 19 resurfacing of 20 miles of roadway in 2021. That 20 is under the leadership of Mark Hall and his 21 outstanding staff.

Town Clerk, Joe Pedi, who is with us here tonight, too, he will continue to seek a grant for, and hopefully implement, a record scanning and retention system which we've been

2 working on for some time.

I will continue to lobby Albany to find 3 alternate sources to subsidize education as the 4 burden of school taxes is excessive on just the 5 property owner or the homeowner. And the Board 6 7 and myself will continue to keep taxes low without reducing services to the residents. 8 9 That's basically it for me. It is not 10 just me, but everyone on this Board. 11 It is Joe Pedi -- his lights just went 12 out. There he is. He's back. Joe, I'm going to 13 ask you to say a few words, too. You're the only 14 one that hasn't. 15 Happy new year to everyone. 16 Joe, do you have anything or not? 17 MR. PEDI: No. No comment, Gil. Thank 18 you very much. 19 SUPERVISOR PIAQUADIO: All right.
