1. This is an initial appearance before the Board. The project proposes a 6,158 square foot building expansion off the southeast corner of the existing Walmart Supercenter.
2. The project site extends across Town of Newburgh / Town of New Windsor municipal boundary. The survey plans Sheet 2 of 2 depicts the majority of the work within the Town of New Windsor. Attorney Cordisco's comments regarding lead agency for review should be received.
3. The Town boundary is depicted on the aerial Photo Sheet C010 and the Survey Sheet 2.
4. Health Department approval for modifications to the water system on the site is required. Water Department review of the revised water system should be undertaken. The water system for the site is served by the Town of Newburgh.
5. The EAF identifies potential habitat for protected species including Indiana Bat and Upland Sandpiper. Coordination with NYSDEC should be undertaken regarding potential impacts to these species.
6. Any modifications to the stormwater management system should be identified. Any treatment areas receiving flow from the construction area should be identified on the plans. Confirmation that all activities proposed are currently covered with impervious surfaces should be received. Any additional runoff must be addressed.
7. Any additional sanitary sewer flow from the site should be identified. A City of Newburgh flow acceptance letter for any increased sanitary flow is required.
8. Limits of disturbance are identified at 0.53 +/- acres. Disturbance greater than 1 acre will require coverage under the NYSDEC Construction Stormwater Permit.
9. The Planning Board should determine whether Ken Wersted's comments on internal traffic should be received.

10. The project submission identifies that a parking variance will be required within each municipality. Parking calculation identifies 912 spaces exist where 1,044 are currently required and under the proposed condition 1,074 spaces are required, where 877 spaces will be provided. Noted the Parking Analysis utilizes the Town of Newburgh parking requirements at 5 per 1,000 square feet.
11. County Planning referral will be required.
12. Planning Boards Attorney comments regarding architectural review of the structures should be received. Architectural review may be required based on decision as to which municipality will be lead agency for review.
13. Proposed parking spaces are identified as 10 x 18 slightly larger than Newburgh standard. Double striping appears to be proposed. Detail for the striping should be provided.

Dear Mr. Ewasutyn and Members of the Board,

On behalf of the applicant, Walmart Inc., Colliers Engineering & Design is pleased to submit the following items for site plan review. The proposed site improvements to the Walmart Store #2104 located at 1201 NY-300, Newburgh, NY 12550, in the IB Interchange Business zoning district, will be conducted in conjunction with an architectural building expansion. The existing store is 208,711 square feet and the proposed building modifications include a 6,158-square-foot addition to the south side of the existing building in place of the existing building sidewalk and existing drive aisle. The new store floor area will be 214,869 square feet. This increase adjusts the building lot coverage to 12.7%; the code requires a lot coverage of 30%. The site work will include associated grading, striping, and signage work. The proposed project will result in 0.53 acres of disturbance, and there will be minimal changes to existing drainage patterns, no SWPPP will be required. The proposed expansion aims to expand the building to facilitate better online pickup and delivery operations for the store.

The proposed site work includes the demolition of existing OPD parking lot canopy and a landscape bed at the front of the store, within the expansion footprint, which will be demolished. The building-mounted Pickup sign will be relocated to the new expansion wall, and a concrete stoop will be constructed at the proposed OPD entrance door. The watermain will be relocated to accommodate the expansion, as shown on sheet C110. All roof drains will be connected to the existing storm system, and both the grease trap and existing storm infrastructure will remain in place. Additional pickup wayfinding signage will be installed throughout the parking lot to improve customer navigation. To support the expanded area, one light pole has been relocated, and an additional fixture head has been added to an existing pole. The lighting design prioritizes safety for customers and associates and has been developed in accordance with local codes; photometrics for the proposed poles are provided on the C160 Lighting Plan.

The proposed changes to the online pickup and delivery (OPD) area, which can be seen on sheet C100, result in the number of pickup spots onsite changing from 29 to 45. The existing

standard parking spots on site are 9.5ft by 18ft, and the proposed pickup spots on site are 12ft by 18ft. These have resulted in a decrease of 35 overall parking spaces as seen in the table provided on C100. The overall parking spot count on site will change from 912 to 877. The existing parking ratio is 4.4, which will change to 4.1. The proposed parking ratio does not comply with the town code of 1 per 200 square feet of gross leasable floor area. We require a variance for the parking space count.

We appreciate the Town of Newburgh's consideration of this proposal and respectfully submit our site plan application for planning board review. We believe the proposed improvements are consistent with the town's design standards and zoning requirements, and we are committed to working collaboratively with staff throughout the review process. We are working with the Town of New Windsor's Planning Department as well, as the property is located within both jurisdictions and was originally approved by both towns. We request to be placed on the next available planning board agenda. 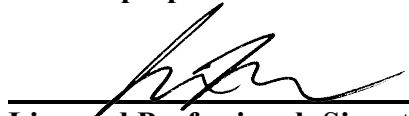

Under no circumstances shall the escrow include amounts attributable to any costs incurred by the Town prior to the effective date of this local law.
- (b) Once computed and established by Resolution of the Planning Board, the applicant shall, within fifteen (15) days of said resolution, post escrow fees with the Secretary of the Planning Board. Failure to deliver the said escrow fees may result in delay of the further processing of the application.

SEVERABILITY

In the event a court of law determined that any provision of this chapter is unenforceable, then only that provision shall be affected and all other provisions shall be fully enforceable.
